Hi Will,

My sincere apologies. I was out for a couple days last week and I am still trying to catch up on all the emails in my Inbox. (It's almost not worth taking time off when you have twice as much work waiting for you when you return, you know? But I really needed two days off!)

Regarding your change request:

Before I give you the brush off (just kidding) - more accurately, before I pass you over to the new Product Manager for OpenCCC account system - I'd like to know a bit more about the specifics of your request. Where do you see this new "Preferred pronoun" field appearing in the application process? What questions would this align to? Legal Name? Preferred Name? or somewhere else?

I should update you on what's happening around here because it will make a difference - and ultimately affect whether this can be implemented or not for the application for admission.

Currently, a new version of OpenCCC Account system is under-development. A new Product Manager, John Sills, and development team is designing the new Account system - with the intention of increasing security, simplifying the account creation process, and moving or deprecating some of the account profile fields (ultimately). We are currently working on how this new system will affect CCCApply and whether Apply will need to absorb some or all of the fields that the new Account system will no longer be collecting. For my part, I am doing data analysis on how often these fields are answered and I'm also working on a college-user survey to determine how these fields are used on your end and whether there is a high need to move them into the Application-proper, or deprecate them.

For example, the new Account system is not planning on collecting the student's "Previous Name", SSN, Second Phone number, and neither of the "Phone Extension" fields. Apply is obligated to include the SSN question (new redesign coming in the upcoming release) in the Standard Application; thus, we will be moving that question into the Standard Application and implementing auto-population (phase 1 for sure) for returning students. We also plan to add "Previous Name" because we believe colleges need that information to reconcile transcripts and other legal requirements.

So, if I could get a bit more information from you on this new request - and possibly get you to complete the CCCApply college survey - that will greatly help me determine whether this is a "must have" need - that the majority of colleges will need - and plan to add it to CCCApply application; or if this is a "must have" need that should be added to the new OpenCCC Account system - and ultimately be included in both Account Creation and Edit Account.

I apologize for the long response; I felt I needed to clarify and provide some context as to why CCCApply may or may not be able to implement this change request.

Are you available for a quick Zoom call this Friday at 11:00am or 1:00pm (this Friday, April 24)?

**If not, how about sometime next week? If next week, can you propose a date and time that works best for you?
Thanks!**

One last reminder, either way Will, if this does get approved to be added to CCCApply or the new OpenCCC system, the very earliest we could implement any new fields would be September. And if that is the case, we really need to hustle on the requirements and communication to all our dependent systems to ensure they can accommodate new fields (SuperGlue, Data Warehouse, Report Center, etc.).

Thank you so much. I look forward to hearing back from you and thanks for bearing with the long email.
