#### **Dual Enrollment Trends**


- Year-over-Year Growth

- I have no preference as long as the requirements for our dual enrollment students are addressed



# Requirements for Top Priorities

- 1. Eliminate non-applicable sections
- 2. Provide clear prompt to ensure students transition from account creation to application
- 3. Simplify language to 6th grade level

#### Runner up:

Identify students with IEPs



#### **Additional Survey Suggestions:**

- 1 Make sure students with two last names, or hyphenated, use only their legal name to match their high school name and their DE college application. This will help immensely with FAFSA, transcripts, etc.
- 2 Create a dual enrollment form workflow complete with parent approval/signature and high school principal signature. Course approval needs to be specific so course selection needs to be from a state database and kept up-to-date.
- 3 There are too many questions in the Dual Enrollment app. Students should not have to select a major just asked what Dual Enrollment class they are taking. If students choose Dual enrollment for a specific term, why are they asked if they have ever attended college? Application should all be on-line application no paper a one stop shop eliminate questions that don't make sense to them. Have a place for parents and student to sign at the end of the application
