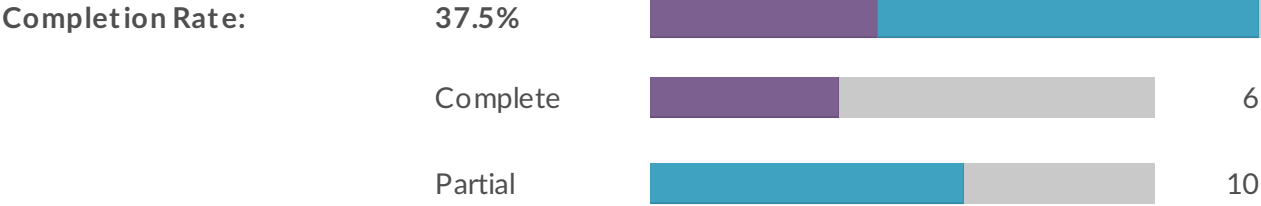


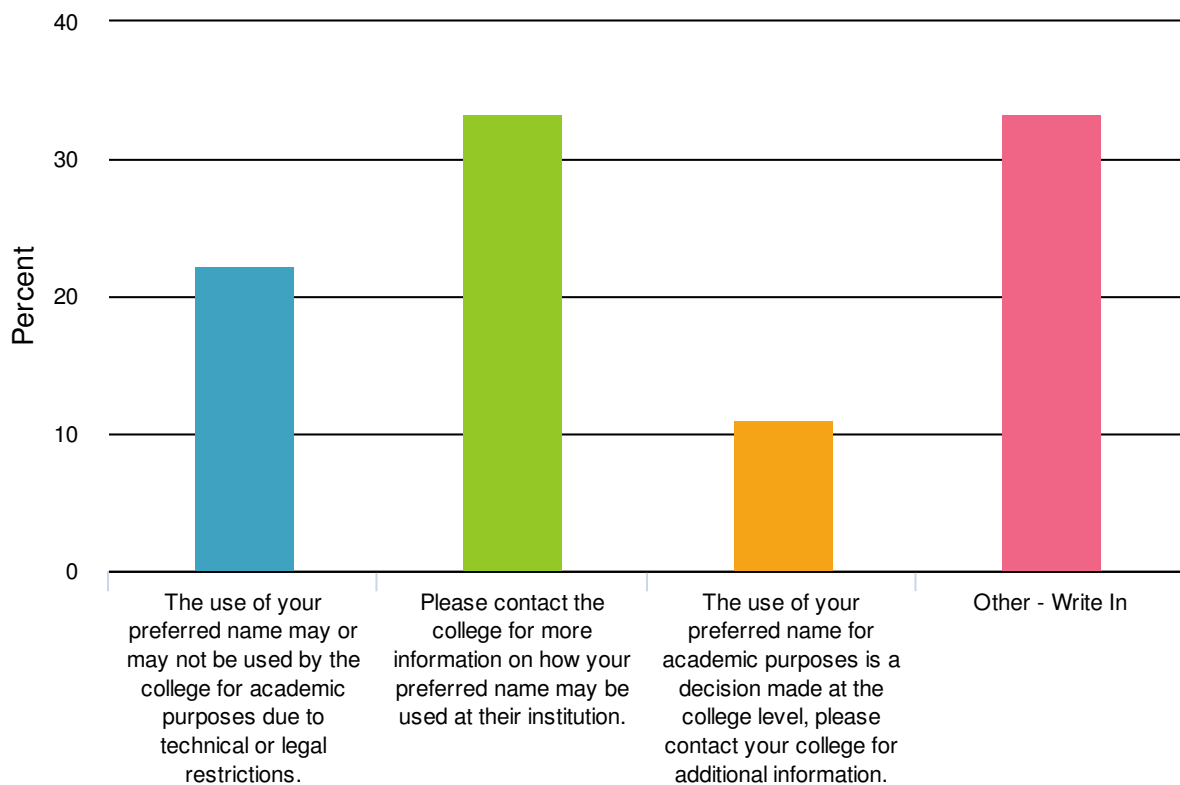

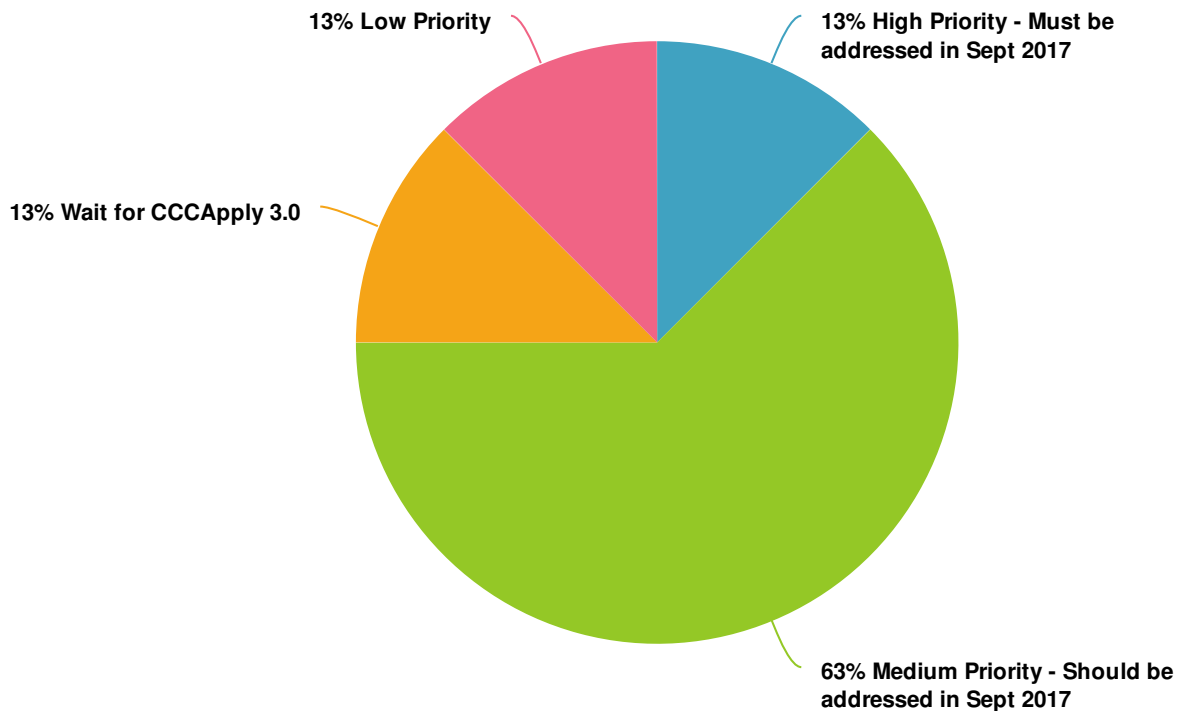

Application: OpenCCC Account Click the link to see the full CR#: 2017-19 Section: Preferred Name Issue: Citrus College is requesting that we revise the additional question text for the "Preferred Name" fields n OpenCCC. They believe that our current language implicates CCCApply in a way that may not be applicable by all colleges. They want us to soften the tone of the language and direct the student to the college Admissions office for more information about how the Preferred Name is used at their college. The current language that appears on Page 1 of the OpenCCC Account is: "Do you have a preferred name that is different than your legal and/or previous name? Note: Not all colleges may allow the use of preferred names for official academic purposes due to legal or technical restrictions." Deferred at March 2017 Meeting: This issue was discussed in March and it was decided that Steering members should work on some suggestions and bring them back for the April 26 meeting. 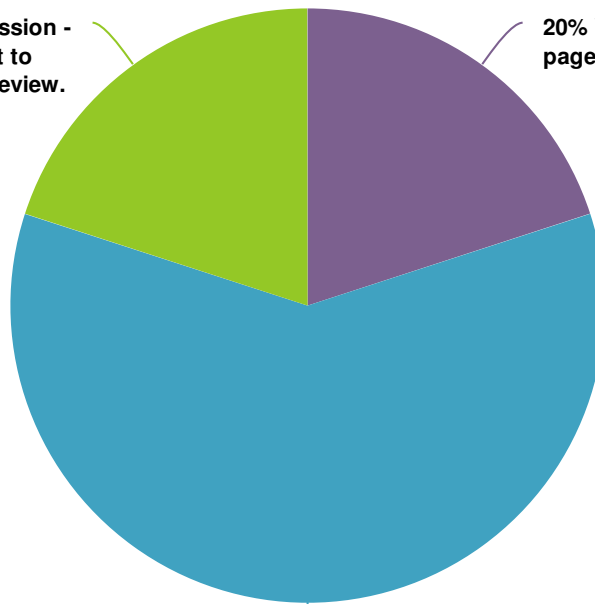

3. Title: Display the Residency page for all users regardless of their Citizenship Status
 See full Change Request: CR# 2017-12
 Application: Standard App Only
 Section: Residency Issue: Santa Rosa Jr. College is requesting that we revise the logic in the Standard Application to display the Residency page ALWAYS, even if the user is a Visa holder, so that the residency information is available once the Visa information is confirmed. For all students, no matter what their citizenship status is, we always need the Residency page questions to be answered so that when a student brings proof of their citizenship/visa type we can just supplement their application with their citizenship/visa USCIS documentation. A sample visa type to test in CCCApply is "H-1"
 Background: Currently, the Standard Application has skip logic coded to "Do not show the Residency page and remove all validation requirements" IF the user's Citizenship status = Student Visa or Other Visa.
 INSTRUCTIONS: Select Yes, No, or Need Further Discussion if you believe CCCApply should remove the skip logic to hide the Residency page if the user indicates they have a Student Visa or Other Visa in the Citizenship Status field.

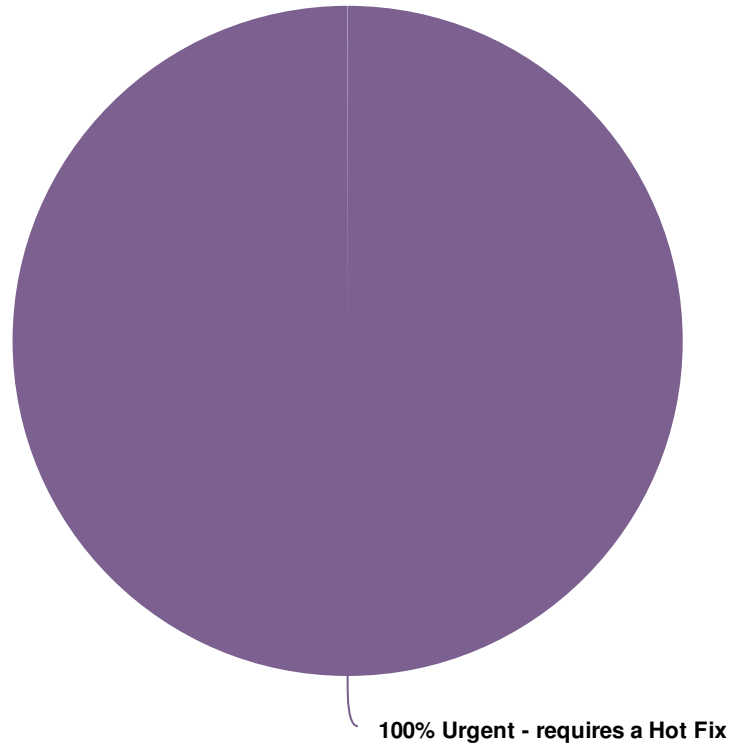

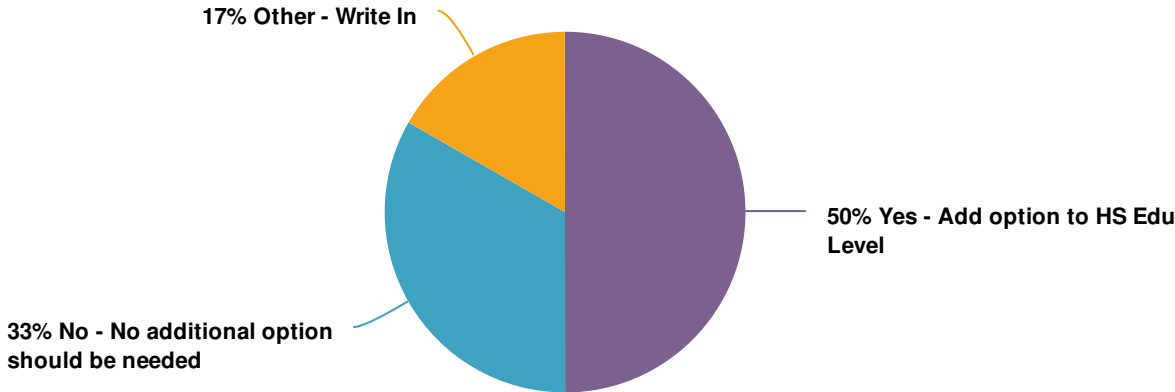

For example, some American Embassy schools and US military schools are located in foreign countries. Students are not sure which HS Education Level option to select and often choose "Received diploma from a foreign secondary school" - when they should be selecting "I received a diploma from a US high school". 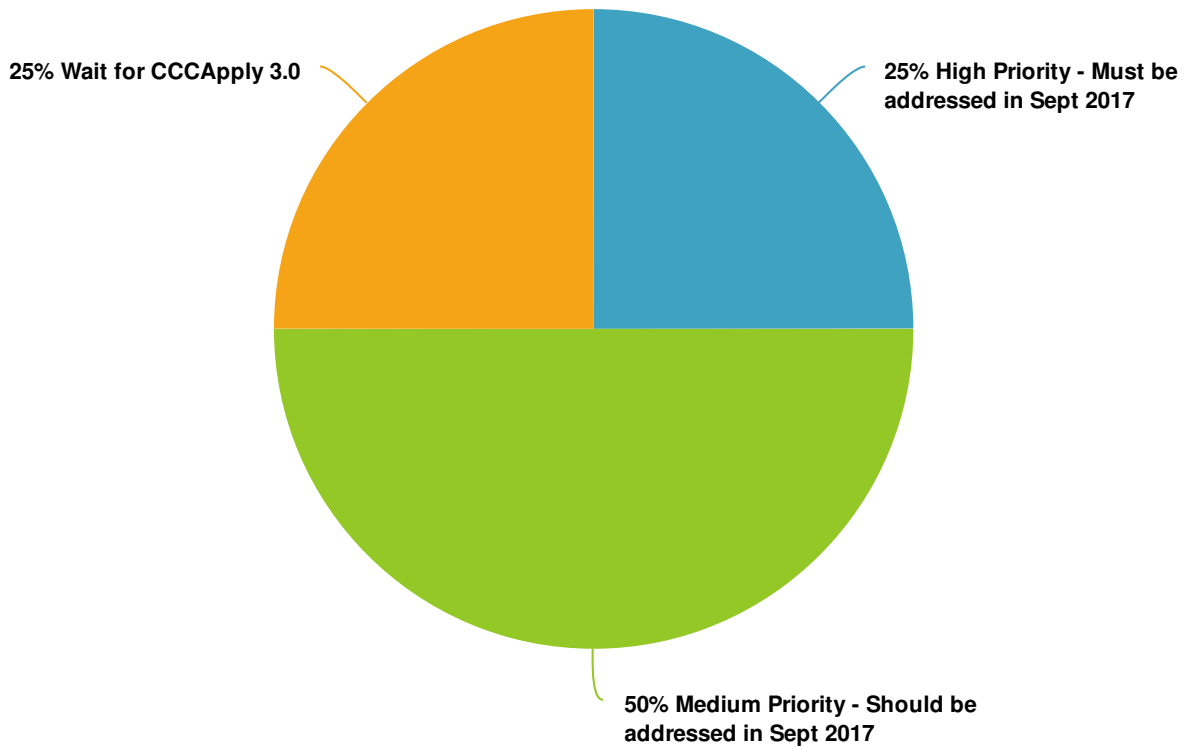

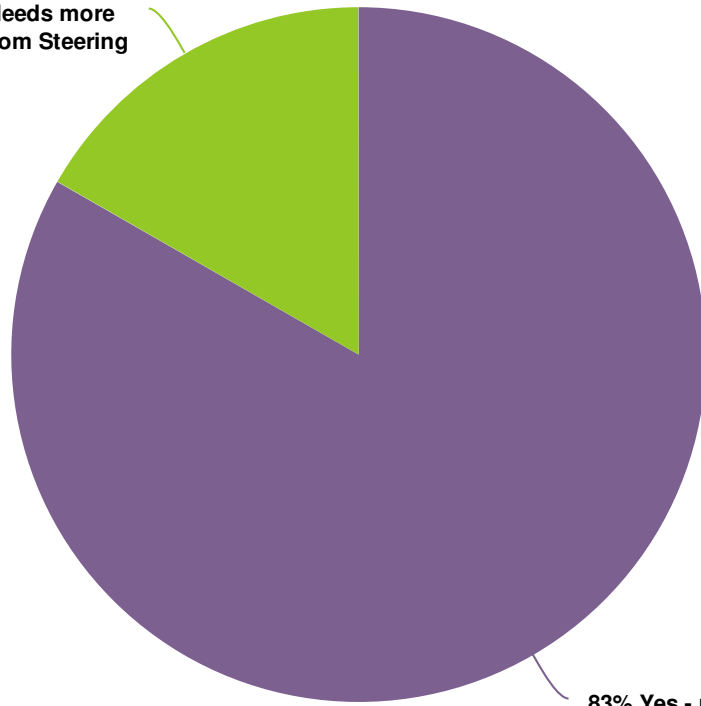

8. Title: Remove the "Have you attended High school in California for 3 years or more" if the user is a high school student. See more information in the CR# 2017-08 Application: Standard Application Only Section: Education Data Field: cahs_3yrs ISSUE: Currently, the Standard Application logic calls to display the question, "Have you attended high school in California for 3 or more years" ALWAYS. Several requests have come in to have this question removed if the student selects the High School Education Level response: "I will be enrolled in high school (or lower grade) and college at the same time." indicating they are in high school at the time of the RDD. NOTE: The question/data field is NOT included in the Residency algorithm at all. It IS used in the AB540 algorithm, however removing it for high school students won't matter for AB540 because that logic also requires the student to be a high school "graduate" or equivalent. Please review the change request document CR#2017-08 to see the Data Specification details (how this field is used in the AB540 logic, as well as the conditional logic specs in general). Proposed Solution: Should this question be removed from the screen if the user selects "I will be enrolled in high school (or lower grade) and college at the same time."? INSTRUCTIONS: Answer Yes, No, or Needs further review to remove this question from the application if the user is still in high school?

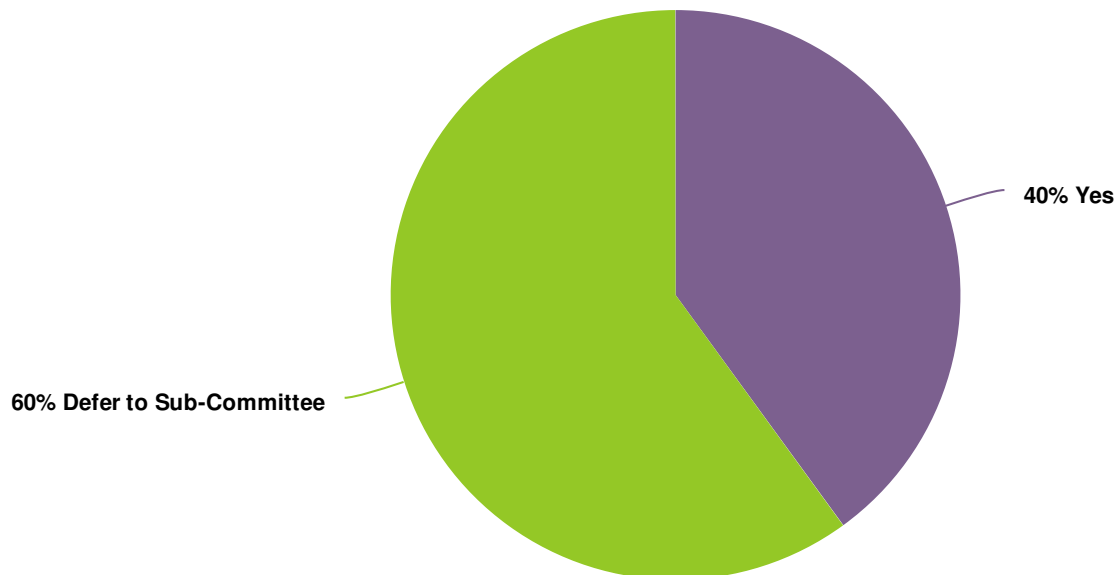

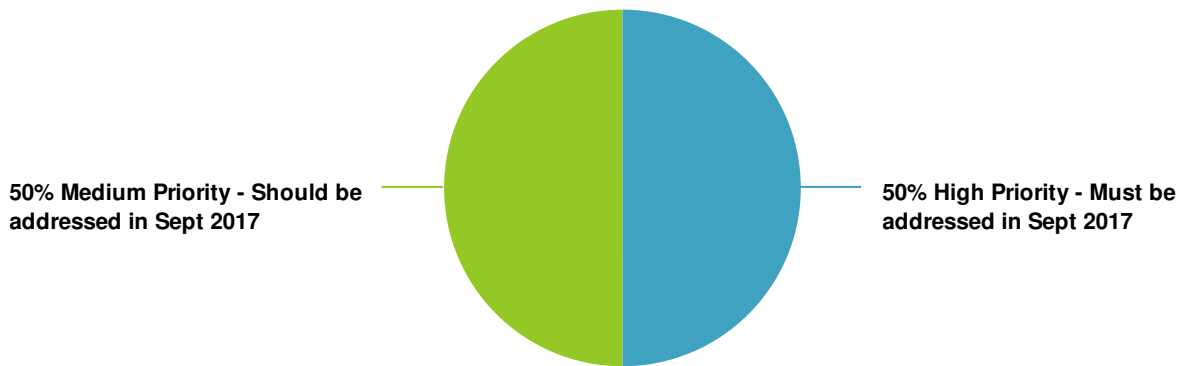

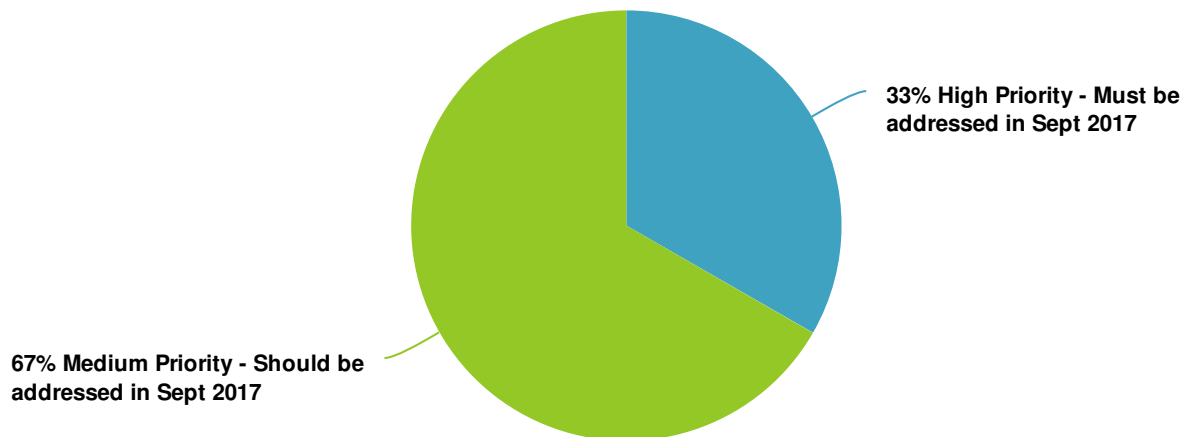

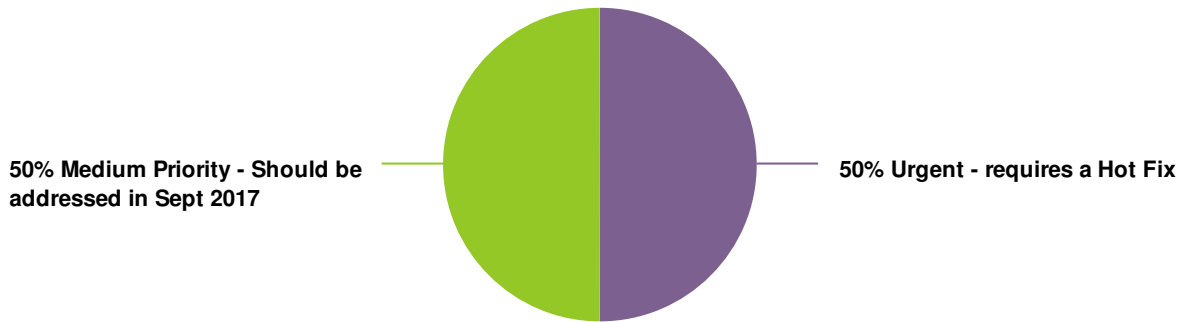
