
The online gateway to the California Community Colleges



CCCApply Administrator

- Colleges manage application settings
- Back-end configuration of Terms, Majors
- Application reads data from table
- User authentication
- Reset Downloads
- Custom Email & Error Msg Rules





Administrator 2.0

"One Administrator to Rule Them All"

- Integration with all CCC applications (Course Exchange, Assess, CCCApply, Canvas, Glue, CVC)
- Share common elements: terms, majors, college info, etc.
- Central authentication & user management
- Integration with SSO Proxy
- Upgrade in line with new CCCApply applications RFP 2017





OpenCCC Account - CCCID

- Statewide Federated Identity Initiative
- Generates unique student identifier = CCCID
- Integrates with future CCC apps
- Catches duplicate accounts & applications
- Future MIS Data Integration
- Supports CCCCO research & student services






- Launched Standard App in 2012

CCCApply History: In the beginning...

June 2000

A task force is formed to discuss creating the first online application for admission for all California Community Colleges.

CCC E-Application

Developed by the Xap Corporation

Steering Committee is born

The colleges represented were Butte, Contra Costa, Cuesta, El Camino, Modesto, Santa Rosa, Yosemite, and Yuba. The Chancellor's Office was also represented.

OpenCCCApply: A New Beginning...

Sept 2012

Master contract with Xap Corporation expires, allowing CCCCO to develop new version of CCCApply around their residency algorithm.

2012

The CCCID is launched

The OpenCCC federated identity initiative is released in front of new version of the application to college: OpenCCCApply




Annual Updates

Release cycle since 2001

Annual Update = March

Supplemental Release = September



History: BOG Fee Waiver Application

2014

Sept 2014

A task force is formed to discuss creating the first online application for admission for all California Community Colleges.

Chancellor's Office BOG

The online BOG Fee Waiver application is based on the annually-approved paper application and the financial aid year cycle.

History: International Application

March 2016

The International admission application is launched completing the CCCApply Suite; emphasis shifts to supporting other statewide programs and building the SSO Proxy.

Begin Maintenance Mode

2016

With the International Application release, CCCApply goes into maintenance mode – only state & federal mandates, bugs, and technical upgrades are developed.

2016: Supporting New CCC Applications

September 2016

CCCApply team focuses on support, supporting other CCCTC web applications and preparing to move to Amazon Web Services

Single Sign On Proxy

2016

In order to provide secure single sign on for all CCC web application, developed and launched CCC SSO Proxy to help gather CCCIDs



2017 Annual Update SSO Proxy

College integration with the OpenCCC Federated Identity

- Facilitates existing students to create OpenCCC accounts (CCCID)
- CCCIDs passed with college IdP to CCC Applications
- Supports reporting and tracking of student data across CCC Apps

Meanwhile, CCC Tech Center goes to RFP to enhance CCCApply with new mobile version for multiple languages.



- Bug fixes






2017 Annual Update

Process: Prioritizing Requirements

- Value vs. feature
- Needs vs. Nice to haves
- Prioritization
- Timeline determined by number of stories



Agile Process: Gathering & Estimating Stories

- Gathers the prioritized stories
- Learns to say No: Deciding what not to build
- Collaborate with team and stakeholders to size the stories
- Bigger isn't better: Value vs. Size
- Release early and often
- Value vs. size
- Assessing risks business, scale, schedule




