



# Shibboleth IdP V3 Upgrade

#### What is it?

OpenCCC Identity Provider (IdP)

- Student sign-in to OpenCCC Account System;
- Generates CCCID
- The gateway to CCC single sign-on for students across all secure CCC web applications
- Upgrade to the central authentication IdP for OpenCCC








# Shibboleth IdP V3 Upgrade

Why Upgrade? Version 2 no longer supported by Internet2

- Reached "end-of-life" on July 31, 2016
- Version 3 will support student single sign-on (SSO)

# FAQ about Shibboleth V3 Upgrade

### What does the college need to do?

• There is nothing the college needs to do. The OpenCCC IdP upgrade will be seamless and transparent to students and colleges.

### Do colleges have to upgrade during the 30 Day Preview?


• No. Colleges don't have a deadline to upgrade but should be aware that the Version 2 of Shibboleth is no longer supported by Internet2.

### What will happen if we don't upgrade right away?

 Nothing will happen, but there are benefits to upgrading as soon as you can, including participating in the CCC SSO Federation..

### What is the SSO Proxy?


Helps ALL students get an OpenCCC Account & CCCID

#### What is the SSO Federation? Facilitate SSO for students and staff

- Federated identity management across all CCC's and system-wide technology applications
- Single Sign-On (SSO) for students and staff for all applications

### Why is it important?

- Simplifies student experience
- Simplifies college IT management




### **New Password Reset by Email Option**

### What is the new option? Self-service Account Recovery by Email

• If the user cannot remember their security questions, they can request a link to reset their password.

### Why? Reduce number of support calls to OpenCCC Helpdesk

- 6% of submitted applications resulted in support calls to Helpdesk
- 3.8% of those calls are for Account Recovery (Password Reset)
- Students forget their username, password, and security questions



# **Bug Fixes & Other Technical Changes**

### Why? Issues reported by users are fixed

- Data quality issues needed to be addressed
- Address bugs critical to residency (current & permanent addresses)
- Typos and text fixes throughout applications

### **DEMO:** High-priority bug fixes are demonstrated

- Timestamp removed from date fields in Email rule messages & reports
- Null values replaced for missing first, middle, last names in rules emails
- Footer "Help" hyperlinks




# Bug Fix: Null Values Displaying in Email Messages

#### What was the bug?

 Null values were displaying as HTML code in Email rule messages;

#### What is the fix?

 Code for Null values are no longer displaying for "No first name" in Email messages, such as Account creation confirmation emails.





### Bug Fix: Timestamp removed from date fields

#### What was the bug?

 The timestamp, in military time, was displaying in Date field responses in Email rule messages.

#### What is the fix?

 Removed the timestamp from non-system generated date fields so that they will appear as dates only in Email messages. From: from@mycollege\_edu




### **Accessibility Enhancements**

Why? Commitment to Accessibility for All Users

- Core aspect of development & design
- 2015 accessibility audit requirements
- Support screen-readers, keyboard users and assistive technologies

The changes made in the Release 5.5 updates and corrects the accessibility of several interface components, including improvements to keyboard navigation across browsers as well as focus enhancements to buttons and form fields.



# High School / College Finder Widget

What is it? Advanced-search look-up tool that displays high schools and colleges with corresponding CDS and CEEB codes in the download file.

### Why? Previous widget not compliant with WCAG 2.0 AA

- 2015 accessibility audit requirements
- Support screenreaders and other assistive technologies

How? Complete re-write of widget code for screen-readers and keyboard users DEMO: New School Finder Widget

# Revision to Area B Residency Logic

#### What was the issue? Residency calculation errors

- Colleges reported inconsistencies in the final residency status
- NEW Residency Steering Sub-Committee identified issue in Area B
- Related to "Out-of-State" indicators for certain populations

### What changed? Updated logic and added new step to Area B

- Changed Step 1 to "Class B2 = Possible Resident"
- New Integrity Flag 30 for "Out-of-State" activity
- New step added to final calculation to ensure Non-residents are classified correctly.



### Update to Area B Logic

Step	Evaluation Statement	Data Elements & Logic	If Yes	Old Logic If No	NEW LOGIC IF NO
1	Do out-of-state indicators support intent?	ca_outside_tax = 0 AND ca_outside_voted = 0 AND ca_outside_college = 0 AND ca_outside_lawsuit = 0	Go to step 2	Class BO (go to step 2)	Set Class B2 (set new flag 30) (go to step 2)
2	Has the applicant lived in California for two years prior to RDD?	ca_res_2_years = 1	Go to step 5	Go to step 3	NO CHANGE

### Update to Area B Logic

#### What is it?

- OPTIONAL implementation to collect high school transcript information to support assessment placement for CCCAssess
- Governed by CAI Steering Committee & CCCCO
- New HS Transcript section on Education page
- 8 new questions and downloadable data fields
- Questions only appear if student meets qualifying criteria

### Why? Support for Common Assessment Initiative (CAI)

- Legislation behind this: SB1456
- Need data for multiple measures



#### **Conditions for Display**

Questions will only display if the student meets one of the following conditions:

#### **Condition #1: High School Senior**

 High School Education Level = "Will be enrolled in high school (or lower grade) and college at the same time"

AND

High school Country = United States



### **Conditions for Display**

Questions will only display if the student meets one of the following conditions:

#### Condition #2: HS Grad (or equivalent) with 10 Years of RDD in US

High School Education Level is one of the following:

- Received high school diploma from US high school
- Passed a high school equivalency test
- Received a Certificate of California High School Proficiency;

#### **AND**

High School Completion Date is < 10 years from the RDD (high school completion/graduation is less than 10 years prior to the day before the first day of the selected Term).

#### AND

**High School Country = United States** 

- According to Title 5, all California Community Colleges must use multiple indicators and sources of evidence of student ability for the purposes of placement into English and Mathematics curricula (This is known as "multiple measures").
- Currently, many colleges are tapping-in to verified data from Cal-PASS
  Plus to access the data points to generate a placement that includes
  multiple measures. In some cases, there may be a significant portion
  of the student population not served by the verified data.
- We are adding a group of high school transcript data questions that ask the student about their academic background within the areas of English and Mathematics. The questions align to the decision trees piloted through the Multiple Measures Assessment Project (MMAP).

- The responses will allow a student to self-report the data points that are needed to generate a placement recommendation based on the Multiple Measures Assessment Project (MMAP) decision trees.
- Colleges will be able to download those responses into their SIS via the CCCApply Download Client

### What does the college HAVE to do to prepare for this change?

- NOTHING unless they want to implement and download the new fields
- If you are NOT implementing, the questions will still appear in PILOT site for 30 Day Preview period - then they will go away.

#### **How to Opt-In?**

- Colleges must "opt-in" to participate
- College should contact CCCApply or CCCAssess Product Mgr
- Add data fields and test in Pilot prior to September 30

# Update Your Download Files for Release 5.5 ONLY if you plan to add the new data fields!

### What gets updated?

- Download Format XML Files by College IT staff
- 8 new Multiple Measures data fields (optional)

### How? Add new fields and update Pilot & Production downloads

- Make changes to Pilot download files to test
- See updated Data Dictionary for field specifications
- Update Download Client jar file(s) and test downloads in Pilot
- Duplicate updates to DLC in Production environment
- Release Notes 5.5 Getting to the Download URLs for Pilot & PRod


# Report Feedback During 30-Day Preview
