SUBJECT: MIS Data Submission Updates

SYNOPSIS: This memo is to advise you of changes critical to MIS data collection and processing. Please read the following information carefully.

Dear Colleagues:

The following data element changes will be implemented during the MIS data submission maintenance window scheduled for August 8, 2019 through August 22, 2019. These changes will affect reporting for the 2019-20 academic year and resubmission of data for prior years and terms occurring after the maintenance window. The new and updated data element definitions are attached.

SB Student Basic Data Reporting

An existing element has been amended and one new element has been added. The record length has been increased to 430 characters.

SB04 STUDENT-GENDER has been amended
SB38 STUDENT-EXPANDED-ETHNICITY has been added

SF and FA Student Financial Aid Reporting

An existing element has been amended.

SF21 STUDENT-AID-AWARD-TYPE has been amended to allow for reporting of new award types

- New Award Type: BP = CCPG Fee Waiver – AB19
- New Award Type: GJ = Student Success Completion Grant (CCCCG)
- New Award Type: GX = Other grant: California College Promise Grant (AB19) source
