*Anyone in California seeking a postsecondary education, regardless of what they look like, where they live, time since high school, and their preferred education modality should have on-demand access.*



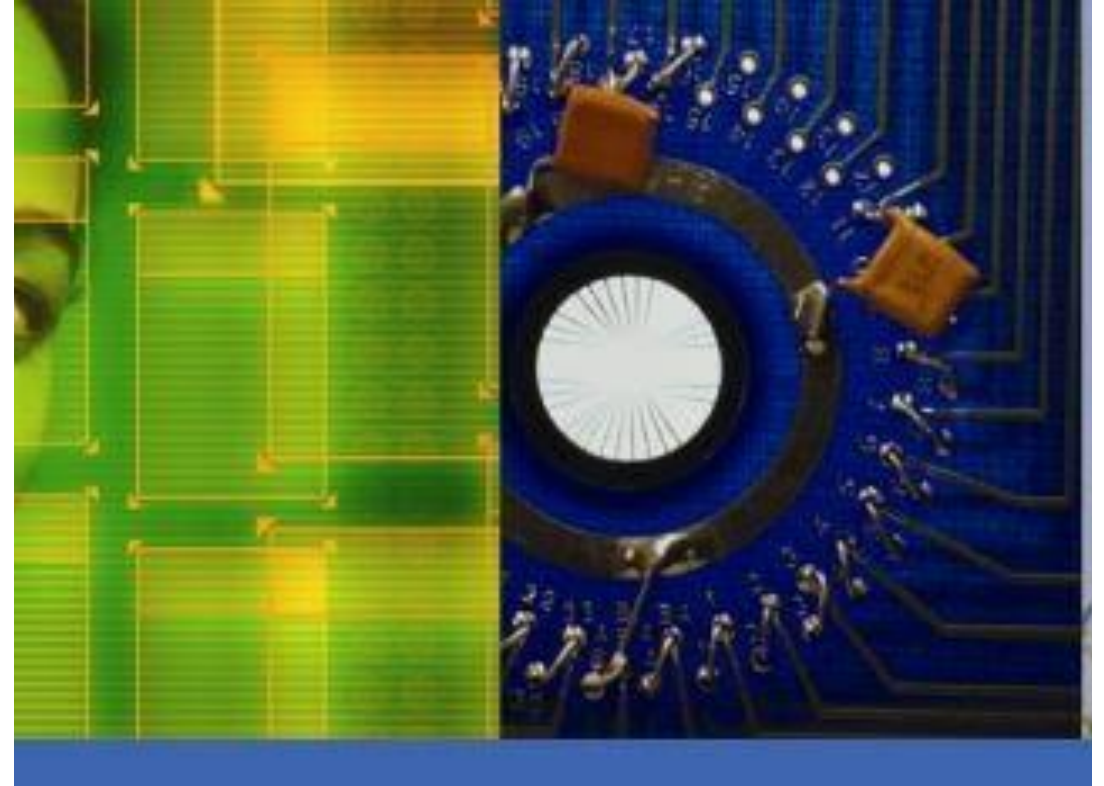

# Long-Known Issues

- Colleges are under-resourced and have significant variation in IT capacity. This is disproportionately problematic for smaller and under-resourced colleges to maintain, deploy and integrate new technology.
- Students struggle to navigate local technology systems that are not more modern. This is amplified when they attend multiple colleges.
- Colleges also have significant reporting requirements - for grants, programs, finance, students and employees, etc. which ensure continued strain on staff



# Overview of an ERP

- **Enterprise Resource Planning**

- Software platform used to manage day-to-day business activities

- Student Administration/SIS Systems

- Admissions Enrollment, Financial Aid, Student Financial Transactions & Records, Counseling, Curriculum Management

- Finance

- General ledger, Chart of Accounts, Cash Management, Receivables, Billing, Project Management, Inventory, Asset Management, Procurement, Grants, and Travel & Expense

- Human Resources

- Core HR, Self Service, Position Management, Compensation, Time & Labor/Absence, Payroll, and Benefits

- Essentially a “one stop shop” software platform for core business functions

- 2018 4CIS Case Study on a Cloud-Based Approach (possible updates)
- 2021 Change Management and Transformation Approach, Roadmap and Budget (Huron) report
- 2021 pilot survey & results
- **Draft** memo describing a common, systemwide ERP

# Systemwide Technology Investment Strategy

- Currently, systemwide technology decisions are done ad-hoc and connection to (student) accessibility is unclear
- There should be more consistent evaluation of new and ongoing technology that is student-centered and equity-focused
- The following Technology Equity Criteria have been identified, but not in very tangible ways (yet)

# Systemwide Technology Equity Criteria

**Access** is the desired outcome of ensuring learning by:

1. *Providing and/or enhancing broadband/high-speed internet on or off-campus.*
2. *Advancing connectivity and reliability of EdTech Portfolio products and services.*
3. *Delivering compatibility and security between technology tools and platforms and student devices within CCC systems.*

**Participation** is defined as the desired outcome of ensuring learning by:

1. *Providing equity-minded accessible content through inclusive language and learned variability accommodations.*
2. *Advancing content to address minoritized student populations.*
3. *Delivering user support to effectively find, identify, evaluate, and use content.*

**Powerful use** is the desired outcome to ensure learning by:

1. *Providing flexible and scalable configuration for inclusive interactions and improves end-user experience and enables actionable feedback and assessment.*
2. *Advancing the entire student experience to address education needs regardless of learners' location, equipment, and capabilities.*
3. *Delivering technology products and services to propel advancement and achievement within every Student Journey.*

How, if at all, should this align with AB508 and DE?

# Requests and Systemwide Technology Investments

- Quick review of various “request” types
  - For information, or RFI - when seeking to learn more about a topic (e.g., Identity Proofing)
  - For applications, or RFA - when seeking to award a grant (e.g., Shared Infrastructure Grant)
  - For proposals, or RFP - when seeking a specific solution (e.g., ERP)
- Potential RFPs for systemwide deployment
  - OpenCCC/CCCApply
  - e-transcript
  - Chancellor’s Office Curriculum Inventory (COCI)
  - Common ERP
  - Others?
