As relevant, issue BOG 10-day Notification of RFA/RFP Release	
Issue RFA/RFP	30 to 60
Application Reading and Rating	7
Intent to Award Posted	1
Protest Period	14
BOG Consent Calendar	
BOG Approval	Every other month
Grant Commencement	Per contract/agreement

Often RFA/RFPs are initiated in December for May BOG approval and fiscal year start (July 1)

## Governor's Proposed Budget FY 22-23

#### New State Attainment Goal

In January, 2022 Governor Newsom declared a goal that 70% of the working-age Californians have a postsecondary degree or certificate by 2030

 What does this mean for the California Community Colleges in the context of technology infrastructure?



#### FY22-23 Joint Analysis Budget

#### Proposal Technology-Heavy Line Items

Proposed Funding Type	Description	Amount
Ongoing	Modernize CCC technology and protect sensitive data	\$25M
	Increase support for financial aid administration	\$10M
One-Time	Implement common course numbering systemwide	\$105M
	Modernize CCC technology and protect sensitive data	\$75M
	Implement program pathways mapping technology	\$25M



#### Chancellor's Office Current Technology Priorities

#### All colleges will:

- Use CCCID on currently and continuously enrolled students
- Enroll students through the CVC Course Exchange as both home and teaching colleges
- Use SuperGlue for bi-directional data sharing
- Implement automated monitoring processes related to fraud, including implementation of IP Quality Score, Okta and/or related tools
