ERP Survey Response Summary

Interview Tracker through 9/18

Interviews Completed: 24

Completed all interviews for Group 1 and 2 Pre-Launch Districts across IT, Finance, HR, and SIS.

Contact List through 9/18

Since the Statewide release, we have received 529 designed contacts across IT, Finance, HR, and SIS from CISOs. Every effort will be made to gather information from these contacts through surveys and subsequent interviews. Some districts have responded to surveys but did not provide contact lists.

Current State Scope and Scoring Dimensions

Through the current state collection effort, we are seeking to validate data from as many districts and colleges as possible to create a comprehensive current state landscape and analysis of the ERP system across the colleges. Our analysis also will focus on assigning capability scores to each district for each function across people, process, and technology¹.

Capability Scoring Dimensions



People

Understanding how the people support the districts ERP

- Transactional vs Strategic
 - Are goals structured to meet day-to-day administrative functions or support the district's long-term objectives?
- Roles and responsibilities
 - How defined are roles and responsibilities within the district (undefined, loosely defined, clearly defined)?
- Resource Capacity
 - What level of capability do current resources have to perform their roles/responsibilities?
- Training
 - Is resource training available and if available, is it structured to meet competency models?
- Appetite For Change
 - Are resources invested/engaged in improving the overall efficiency/capabilities of the system?



Process

Understanding districts ERP processes, level of standardization, and workflows

- Manual vs Automated
 - Are functional processes mostly manual or automated?
- Process Integration
 - How connected are resources, data, and applications across functions?
- Process Standardization
 - Are functional tasks, approaches, and administrative steps organized/documented?
- Reporting Automation
 - Does reporting require data manipulation/manual input from multiple departments or is it mostly automated?
- Process/Workflow Measurement
 - What SLAs and KPIs exist to assess performance and efficiency?



Technology

Understanding districts ERP and ancillary systems, and the accessibility, reliability, and governance of data

- ERP Customizations
 - Is the ERP "off-the-shelf" or has it been customized? If customized, how customized is the ERP?
- Ancillary/Shadow Systems
 - How dependent is the district on ancillary/shadow systems to perform functionalities?
- Data Accessibility
 - Is data generally available/accessible to resources?
- Data Reliability
 - Is data generally complete/accurate?
- Data Governance
 - Are there policies/standards in place to manage the availability, quality, and security of district data?



Course Exchange

Course Exchange

- The Course Exchange was launched to expand access to online courses, namely to help transfer-seeking students complete faster and allow colleges to offer more sections of high-demand courses.
- Primary benefits of the Course Exchange are to:
 - Provide students with greater access to online courses with the goal of reaching systematic decrease in time to completion.
 - Allow colleges to fill (specialized) courses and offer additional sections.
 - Incentivize flexibility for students (i.e., Home Colleges earn completions; Teaching Colleges earn FTES).

Lessons Learned

- Exchange implementation is highly customized and often requires colleges to change/update their technical and student services processes.
- Colleges have competing priorities and IT departments are often understaffed.
- Financial aid offices have concerns around workload and audit risks.
- More unique custom integrations means more knowledge base to learn, train and support.

Looking Ahead

- Repurpose the Consortium Committee into a *Teaching College User Group*.
- Resolve product and production errors and deploy additional product enhancements (e.g., automatic non-resident tuition updates and preferred name information).
- Release streamlined financial aid integration and conduct trainings.
- Stay on track with all cohorts scheduled in 2023 & 2024

FY23 System-level Priorities

- Ensure all colleges and districts are in the CVC Consortium, sign the financial aid agreement, implement the Course Finder API and are part of a Teaching College cohort.
- Revisit key performance indicators to ensure in alignment with Vision 2030 and related goals.
- Understand the role of poor technology infrastructure in Course Exchange implementation.
- Identify any legislative and/or regulatory changes that hinder systemwide implementation.
- Improve documentation and communication about the Exchange.
- Remedy the inability to monitor student “origin” and “destination” institutions systematically.
- Understand the system and/or local value of including non-credit centers/colleges.
- Clarify the potential local and system value-add for expanding to dual enrollment, CSU and out-of-state students.

1. ID Proofing

- Received an additional ID Validation demonstration and ID Proofing rollout update
- SAC suggested TTAC receive an update on school testing and 12/1/23 rollout / Go-Live

2. IT / Technology Staff Impacts - Remote work Vs In Person

- Reviewed limitations felt by colleges to attract talent due to salaries and in person Req.
- Suggested TTAC/CO look at remote policies/stds., tools/phones options to reduce burden

3. Change Management

- Reviewed current status of change management support for colleges
- Suggest TTAC look at refining the CCC intake process to add or turn on feature requests and assign SAC as point for developing/refining the change and awareness process



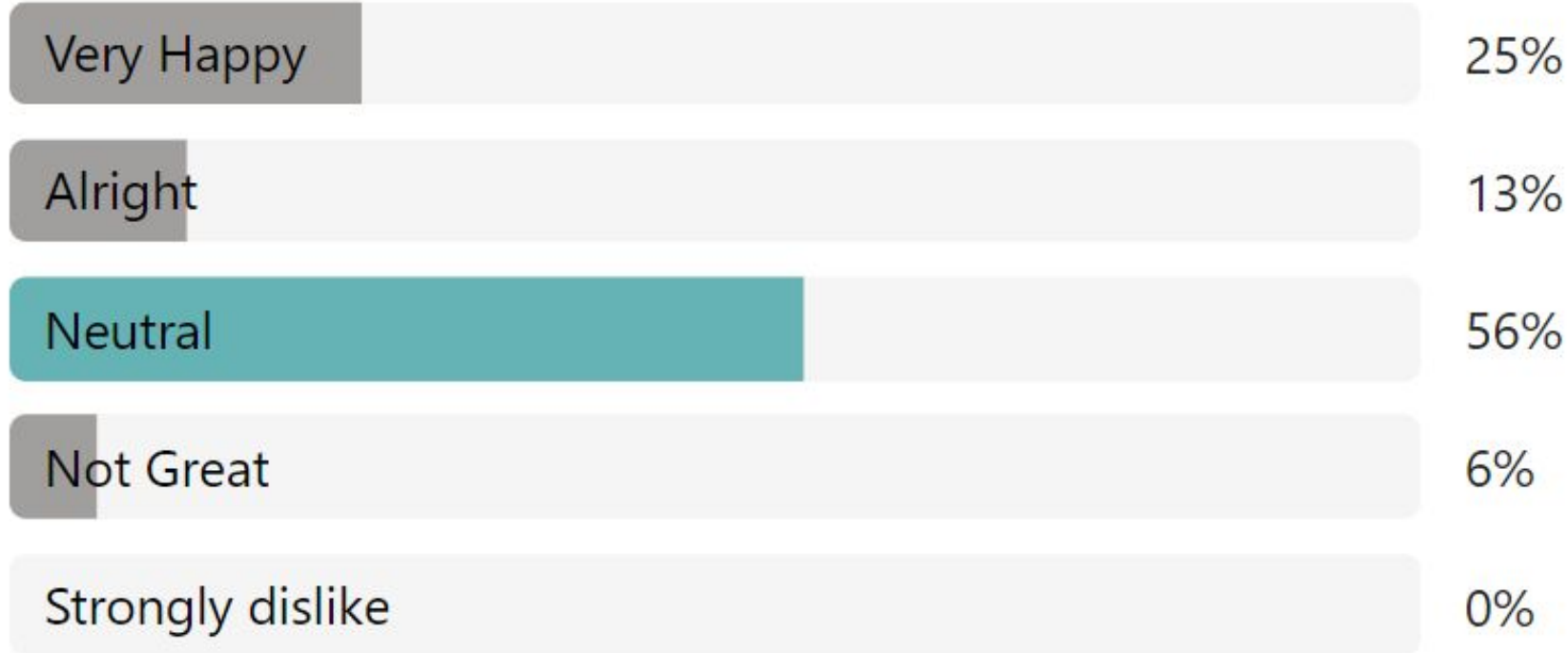
