Yeah, so they did all the technical integration work over the course of several years, but weren't ready for the data integration due to a district-wide PeopleSoft implementation (took about 5 years!).

I'm not sure how they are planning to do the backend piece, but they have deployed with all three college logos in the header/banner - which tells me they plan to use the app as a "district application" and then determine which college the student will actually attend either after submission or before (but that is all customized on their front end).

But officially - all 3 colleges (plus their CE college) are active on CCCApply.

Do you want me to reach out and find out more information about how they are setting that up to users?

P.S. Separate topic, but I wanted to let you know that my sister, Mary Masters, is the IT Coordinator at Oroville High School District (up here near Butte College) asked me about AB705 and how high schools are participating and rolling up data relative to MM.
